# Minutes of the Ordinary Meeting of Orton Parish Council, held in the Village Hall, Great Orton, on Monday 3<sup>rd</sup> July 2023 at 7.30pm.

## 26/23 Apologies

Apologies were received and accepted from Councillor N. Orchard, (work commitments) and Councillor E. Norman (illness).

#### 27/23 Minutes

**It was Resolved that** the minutes of the council meetings held on 15th May 2023 be signed by the Chairman as a true record. (Copy enclosed).

## 28/23 Public participation

Four Great Orton residents attended the meeting. A member of the public expressed concerns about the environmental and road safety impact of creating a footpath along the roadside South East of Roebuck Pastures, Great Orton, as described in planning proposal Ref:23/0222. There were also concerns expressed about the absence of drainage information and the implications of having vehicles reversing out of driveways into the main Great Orton road.

## 29/23 Declarations of notifiable pecuniary interests

There were no declarations of pecuniary interest from members, in respect of items on the agenda.

The Chairman made the following announcements:

- 2) A request was made that parish councillors kindly remove out-dated notices from the notice boards in order to keep them tidy and relevant.
- 3) The final CALC AGM will take place on Teams on Saturday 22<sup>nd</sup> July 2023 at 10am: all parish councillors are urged to attend.
- 4) Orton Parish Photograph will be taken on Sunday 9<sup>th</sup> July 2023 at 2pm on the green in Great Orton; all are encouraged to attend.
- 5) Riverside Housing Association seems to be unaware of the existing Section 106 agreement that they must notify the Parish Council of any vacancies which arise. This is to be investigated further in time for the next parish council meeting.

## 33/23 Reports

#### **Cumberland Councillor Allison Report**

Councillor Allison reported that:

- (a) A meeting between local residents, parish councillors and Cumberland Council Highways staff had been arranged to agree the location of 30mph signs at Mains Fauld.
- (b) Planning application ref: 23/0222 (Erection of 3no. detached dwellings, associated access & landscaping on land South East of Roebuck Pastures, Great Orton, Carlisle). had been called in.

## **School Report**

The Chair of Governors, said that the school children have been carrying out a number of activities aimed incorporating them into the wider community. They have also undertaken a number of varied sporting activities. A recent trip to a synagogue was very informative and interesting. There was some discussion about car parking outside the school and also the possible impact of the forthcoming nursery provision. Various possibilities were discussed with regard to the walking school bus, parking at the village hall, on the green, at the Wellington Inn and shortening the zig zag lines.

#### **Village Hall Committee Report**

The Village Hall Committee representative reported that Whist has been cancelled but this should be temporary. A review of costs is to be undertaken at the next meeting and it is noted that electricity costs have risen by 140% this year.

#### **Watchtree Report**

The Watchtree representative reported that the 2024 calendar was now being produced. The 2023 Christmas Event is to be discussed in the near future. It was noted that the newly re-fenced entrance was attractive and that the new tree with sponsors' names on the leaves looks very effective.
